



2020 Vallee Scholars Call for Nominations – Deadlines February 1 & March 1, 2020

Recognizing that outstanding, early career, independent investigators are the source for future advances in the biomedical sciences and appreciating that flexible funding for basic research is needed, the Vallee Foundation will once again accept nominations for Vallee Scholar Awards. It is expected that Vallee Scholars will be engaged in bold and innovative research. During the grant period, the Vallee Scholar will be invited to two biennial Vallee Scholars Meetings and, in alternate years, to two Vallee Summer Symposia and will be asked to present his/her research on at least one of these occasions. The Foundation expects Vallee Scholars to make every effort to attend these scientific meetings and become members of the Vallee Foundation community. Award

This award provides a one-time, career development award of \$300,000 to exceptional, early stage, independent investigators carrying out basic biomedical research. These funds must be expended over a period of four years or less. (Under extenuating circumstances, a one-year extension of the award may be granted.) While relatively unrestricted, no more than 10% of the grant can be used for institutional indirect costs. Use of award funds for salary support of the applicant is not permitted. Salary for others, such as postdoctoral fellows, graduate students and research assistants is allowed, as are expenditures for supplies, equipment, research travel, and childcare while attending scientific conferences. Graduate student tuition payments cannot exceed \$10,000 per year.

Eligibility

This award is available only to investigators nominated by institutions that have been invited by the Vallee Foundation to submit a nomination, and only one application can be submitted per institution. The candidate must have received his/her PhD/MD or other professional degree within 10 years of the application deadline, and by the application date should have been in an independent research position (tenure track or equivalent) for 6 years or fewer. The Vallee Foundation has no restrictions on nominees having received other grant funding. The Selection Committee may at its discretion, however, consider the levels, and other sources, of funding when comparing closely-ranked candidates.

Timetable

February 1, 2020	Deadline for institutions to submit a nomination letter
March 1, 2020	Deadline for nominees to complete online applications.
September 2020	Awards will be announced by early September 2020, with funding provided soon thereafter.

Selection of nominee

Arrangements for the nomination process at each institution are to be made by a research leader at each of the selected institutions. While the details of the selection process are at the discretion of the institution, a full description of the call for candidates and the selection process should be included in the nomination letter.

The Letter of Nomination from the Dean or Department Chair should be sent to the Vallee Foundation (amason@thevalleefoundation.org) no later than February 1, 2020. The letter should include:

- Name and email address of the candidate,
- Description of the merit of the candidate and his or her research,
- Description of the institution's process to select the candidate, including whether or not a committee was convened and the names of the committee members, and
- Confirmation that the candidate is in a tenure-track or tenure-track-equivalent position.

Online Application:

All applications will be administered through Foundant, our Online Grants Management system, where nominees can create an account, draft, save and submit their application, upload documents and reports, and change and control contact information

Once the institution has selected a nominee and informed the Vallee Foundation, the Foundation will provide the nominee with log-on details. By March 1, 2020, the nominee must complete the application form and upload the following documents:

1. **Complete *Curriculum Vitae***. Include degree information, all positions held, research support (institutional and external), awards, and publications.
2. **Research proposal**. The narrative should not exceed five, single-spaced, 8.5"x11" pages of text using 12-point font with a 1-inch margin. Figure legends of embedded figures should be legible. The proposal should include:
 - a) Title
 - b) Abstract
 - c) Specific Aims
 - d) Brief introduction/survey of the field
 - e) Proposed research, including preliminary resultsCited literature can be appended as separate pages.
3. **Budget**.
4. **Two of the nominee's most important papers published to date**. Papers that have not been officially accepted by a peer-reviewed journal will not be accepted.

Applications cannot be changed or modified after submission by March 1, 2020.

The nominee will also be asked to:

- **provide a project summary** (1400 characters - this can be the same as the abstract in the research proposal)
- **explain the most novel and innovative aspects of his/her research** (1400 characters),
- **describe how the Vallee Foundation funding will make a difference to his/her research** (1400 characters), and
- **describe the importance of his/her two most significant papers in advancing the field of research** (1400 characters).

Letters of Reference

Two letters of reference from experts in the field should be sent by the referees directly to the Vallee Foundation via email to amason@thevalleefoundation.org to arrive no later than March 1. It is expected that one of these letters would be from one of the candidate's training mentors.

Monitoring of Grant

Upon accepting the grant, the institution will be responsible for monitoring the selected research project. A brief report describing the research progress and a record of expenditures certified by an appropriate institutional official are required each year.
